

Social Media Sweepstakes for Dodgers Tickets Official Rules

1. Eligibility:

This promotion is for a sweepstakes for one (1) set of four (4) tickets and one (1) parking pass to the Sunday, July 21, 2024, Dodgers Game at the Dodger Stadium in Los Angeles, CA. This social media sweepstakes (the "Promotion") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old or the age of majority in their jurisdiction of residence at the time of entry, whichever is greater. There is no purchase necessary to enter or win. Employees of Rodriguez & Associates, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited. Participation constitutes the entrant's full and unconditional agreement to these Official Rules and Administrator's decisions, which are final and binding in all matters related to the Promotion. 3. Timing:

6. Winner Verification:

In such an event, Administrator reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment. Administrator reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Administrator reserves the right to seek damages from any such person to the fullest extent permitted by law. If, for any reason, Administrator, at its discretion, may elect to hold a random Sweepstakes from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming, or any other reasons prevent the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Administrator reserves the right to award only the available number of prizes by a random Sweepstakes among all legitimate, unawarded, eligible prize claims.

13. Disputes:

Except where prohibited, entrant agrees that:

- (1) any and all disputes, claims, and causes of action arising out of or connected with this Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate California State Court located in Kern County, California;
- (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' or witness' fees or any other costs or penalties;
- (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental, and consequential damages and any other damages, other than for actual, documented, reasonable, and non-refundable out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

The maximum liability of Administrator shall not exceed the actual, documented, reasonable, and non-refundable out-of-pocket expenses of the claimant. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the entrant and Administrator in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules (whether of the State of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of California.
